TITLE: Climate Change Resilience Education Program

DIVISION: Planning & Infrastructure

SUMMARY:

A grant has been provided from the Municipal Climate Change Action Centre to develop an education program about local climate change impacts in Spruce Grove. The following individuals from Morrison Hershfield will join the Youth Advisory Committee on Zoom to seek feedback on the program: Clarissa Huffman, Project Manager and Climate Change Planner, Lexy Relph, and Kieryn Matthews. Avelyn Nicol, Senior Environmental Advisor, City of Spruce Grove, will also be in attendance as lead for the City of Spruce Grove.

PROPOSED MOTION:

A motion is not required.

BACKGROUND / ANALYSIS:

The City of Spruce Grove is developing a program to help communicate climate change impacts and build individual and community capacity to respond to climate change through behavior, decision-making, and choice.

In addition to bolstering the Climate Change Action Plan implementation planning process, this project will also help support several specific goals and actions which have been identified in Council's Strategic Plan. First, Goal 8.a is to "provide educational resources to residents to help them prepare for the effects of climate change". A core outcome of this work is to increase community awareness of climate change and individual options for action.

Strategic Plan Goal 8.c, specifically Action 1, is to "develop an education program for residents about local climate change impacts". A two-way communication approach will be used to

support climate change capacity building. This means that an education program about climate change means not only sharing about local risks and impacts themselves, but also learning about how this knowledge is understood and utilized within the community. Thus, a key part of this process is to engage in an iterative process where the City and the community work together to co-create a community-led response. This approach acknowledges that 'capacity building' is about both having adequate knowledge and the tools required to integrate that knowledge into behavior, choice, and action.

This presentation connects to the Youth Advisory Committee work plan through commitment three, connecting with and protecting the environment.

IMPLEMENTATION / COMMUNICATION:

The program development and pilot are being funded fully (\$78,200) by the Municipal Climate Change Action Centre and there is a funding agreement in place for project delivery.



High Risk Climate

Our Future Climate

Under a high climate change scenario, we could see the following changes to the climate in Spruce Grove by the 2060's relative to the recent past1.



Hotter Summers

Warmest maximum temperature of 36°C (historically: 31°C)

3 heat waves per year (historically: none)

24 days in a year above 30°C (historically: 3 days)



Water Stress

A 168-day long frost-free season per year (historically: 128 days)

Increased drought risk due to hotter summers and invariable summer precipitation



Warmer Winters

One day per year below -30°C (historically: 8)

88 winter days (where temperatures drop below -5°C) (historically: 130 days)

An average of 68 freeze-thaw cycles per year (historically: 89)



More Extreme Weather

Increase in high intensity rainstorms (20% increase in days with >10 mm rain)

More extreme wind and lightning

impacts	1330 3 to the 2000 3
Multi-year Droughts	70% increased likelihood of drought
Heat Waves	Up to 8x more heat waves
Freezing Rain	At least one freezing rain event a year
Hailstorms	Similar future likelihood

Predicted Change from the

1990's to the 2060's

1Strictly speaking, the recent past or "historical" values are the annual average values over the 30-year period 1976-2005 (the 1990's) and the values for the 2060s are the average annual values over the 30-year period 2051-2080. To identify changing conditions across time, climate scientists work with 30-year averages to smooth out the effects of year-to-year variations in weather.




- Use rain barrels at home

- Find out where the closest cooling/warming centers are (e.g., spray parks)
- Connect with your neighbours through the City's block party program

Spruce Grove's MDP, "The Shape of our Community", will guide the evolution and growth of our city over the next 20-30 years.

The plan provides a policy framework to guide and shape growth in the city. It provides direction on future land use, development, urban design, transportation, and other service areas. Typically, topics include:

- Future land use patterns
- Growth management
- Urban form and design
- · Economic development
- Heritage preservation

- Environmental management
- · Housing and neighbourhood design
- Commercial and industrial development
- · Parks, recreation, and culture
- Community and protective services
- Transportation
- Utilities

These plans involve a significant amount of public engagement to ensure the plan reflects the community. This presentation and workshop are part of that overall engagement.

This presentation and activity connect to the Youth Advisory Committee workplan through commitment four, Building a community that supports vulnerable people and people in need, and has opportunities for all residents to feel connected to their community, as well as through bylaw direction to provide a youth lens on youth-oriented City policies, programs, or services.







The Youth Advisory Committee will be receiving a presentation from the City of Spruce Grove Fire Services and Community Peace Officers who work to maintain the safety, peace, and security of Spruce Grove.

PROPOSED MOTION:

A motion is not required.

BACKGROUND / ANALYSIS:

Spruce Grove has an integrated fire service that provides patient transport and ambulance services in addition to traditional fire department services such as fire suppression, dangerous goods response, and other types of response needed to protect property, people, and the environment. Spruce Grove Fire Services also promotes fire and injury prevention through a variety of activities.

City of Spruce Grove Community Peace Officers work within Spruce Grove to provide the following services:

- Investigate municipal bylaws and select provincial legislation <u>complaints</u>
- Enforcement of municipal bylaws
- Enforcement of Province of Alberta statutes, including but not limited to:
 - Traffic Safety Act
 - Gaming and Liquor Act
 - Tobacco Reduction Act
 - Environmental Protection Act

- Trespass to Premise Act
- o Animal Protection Act
- Animal control duties
- Assist RCMP, EMS, and fire services
- Patrolling of residential, commercial, and industrial areas
- Attend special events to assist in public safety and security
- Deliver proactive safety programs in the community

These presentations from Fire and Enforcement Services connect to the Youth Advisory Committee work plan through the commitment to gaining an understanding of a wide array of issues and background information that will provide a strong foundation for recommendations to Council.

Who are Peace Officers?

- ❖ Police Officer, APO, CPO 1, CPO 2, Correctional Peace Officer
 - ❖ Anyone who is employed for the preservation and maintenance of the public peace (def. CC 2 / POA 7(5)/ CCRA)

What is the difference?

- Police Officer
 - CC, Provincial Acts, Bylaws, Police Act
- APO
 - Provincial Acts, limited CC (role dependent) Sheriff, Fish and Wildlife, Conservation
- CPO
 - Provincial Acts, limited CC (enhanced theft under, mischief under, warrants, non-injury MVC), Bylaws (all role/jurisdictional dependent)
- Correctional Peace Officer
 - ❖ A peace officer with authority under the CCRA wherever there is a jail

Powers of Arrest

- Arrest on statutes you have authority to enforce
 - TSA-suspended driver, speeding
 - GLCA-public intox
- ❖ 494 CC
 - Citizen's arrest
 - Finds committing an indictable offence
 - On reasonable grounds believes
 - Has committed offence
 - Escaping fresh pursuit by persons who have lawful authority to arrest
- ❖ 495 CC
 - Not available to Community Peace Officers
 - ❖ Available to some APO agencies (Sheriffs, Fish and Wildlife, Conservation)
- Section 3 POPA
 - All regulations under the CC apply as long as they are consistent with POPA, including search warrants.

How does a municipality hire Community Peace Officers?

- ❖ The Minister may issue an employer's authorization to an applicant and may impose any terms and conditions on the employer's authorization that the Minister considers appropriate, which may include requiring the authorized employer to implement or comply with policies, standards of conduct, practices, procedures, protocols or rules provided for in the regulations. (POA 5(3))
- Minister may, on application of an authorized employer, appoint a person as a Community Peace Officer (POA 7(1))
- The FC is the representative of the authorized employer (role)

a PEACE OFFICER as detailed below:

Article 1. Authority, Responsibility and Duties


1.1 Subject to section 1.2, the person appointed under this document has the authority, while employed or engaged by the City of Spruce Grove and while acting within the scope of his/her employment or engagement, to enforce the following legislation and all regulations thereunder, and serve court documents relating to the:

ANIMAL PROTECTION ACT
DANGEROUS DOGS ACT
ENVIRONMENTAL PROTECTION AND ENHANCEMENT ACT,
(PART 9, DIVISION 2)
GAMING, LIQUOR, AND CANNABIS ACT
INNKEEPERS ACT
PROVINCIAL OFFENCES PROCEDURE ACT
PETTY TRESPASS ACT
TOBACCO AND SMOKING REDUCTION ACT
TRAFFIC SAFETY ACT
TRESPASS TO PREMISES ACT

- 1.2 The authorities granted herein are subject to the following restrictions:
 - a) Authority to enforce the Gaming, Liquor, and Cannabis Act is restricted to sections 83, 84, 87, 89, 90.24, 90.25, 90.26, 90.28, 90.29, 107, 108; and section 115 subject to section 53 of the Police Act.
 - Authority to enforce the Gaming, Liquor, and Cannabis Regulation (AR 143/96) is restricted to section 87.1.

Article 2. Jurisdiction


2.1 The jurisdiction of peace officers employed by the City of Spruce Grove is, subject to their individual appointments, throughout the Province of Alberta, excluding one and two digit highways except as permitted in accordance with section 2.2.



- 2.2 Authority is granted on one and two digit highways within the urban confines of a municipality where the speed limit is 90 kilometers per hour or less.
- 2.3 Authority may be granted on one and two digit highways as follows:
 - With a written invitation by a police or law enforcement agency with authority on that highway for the purpose of participation in a Joint Enforcement Operation.
 - b) When requested by a police or law enforcement agency with authority on that highway to perform traffic management duties but not including enforcement authorities.
 - c) Where permitted by the terms of the peace officer's appointment, for the purpose of performing emergency vehicle response, but not including enforcement authorities.
- 2.4 The jurisdiction of peace officers in Alberta is at all times subject to requirements set out in the Public Security Peace Officer Program Policy, January 2007 (amended February 2012), and as may be further amended from time to time, as issued by the Director of Law Enforcement.
- 2.5 This authorization does not include jurisdiction on an Indian Reserve.

Article 3. Weapons and Equipment

- 3.1 This appointment permits the carrying or use of the following while in the performance of their duties as set out above:
 - OC Spray as defined in section 4(1)(a) of the Peace Officer Regulation, as amended from time to time;
 - A baton as defined in section 4(1)(b) of the Peace Officer Regulation, as amended from time to time;
 - Emergency response units as defined in the regulations under the Traffic Safety Act, as amended from time to time, used by the peace officer for the purpose of carrying out the duties of a peace officer;
 - d) Handcuffs;
 - Personal protective equipment including a bullet resistant vest, a stab resistant vest or protective gloves, but not including SAP gloves or similar gloves;
 - Particular equipment necessary to carry out the enforcement duties and responsibilities of the peace officer; and
 - g) Tools and items necessary for the performance of the peace officer's duties and responsibilities.



Article 4. Title

4.1 The peace officer may utilize the title of <u>Peace Officer</u> or <u>Community Peace Officer</u> while carrying out the authority, responsibilities and duties of this appointment.

Article 5. Terms and Conditions

- 5.1 This appointment expires upon termination of employment or engagement with the City of Spruce Grove.
- 5.2 The peace officer is permitted to exercise the duties specified in section 24.13 of the Public Security Peace Officer Program Policy, January 2007 (amended February 2012), and as may be further amended from time to time, as issued by the Director of Law Enforcement.
- 5.3 The peace officer must abide by Public Security Peace Officer Program Policy, January 2007 (amended February 2012), and as may be further amended from time to time, as issued by the Director of Law Enforcement.
