Extra organics collection event happening November 4 – 8

Doing some fall clean up in your yard? Take advantage of an upcoming extra organics collection event to dispose of extra organics waste. During the week of November 4 – 8, and on your regular waste collection day, residents can put extra yard/organics waste outside next to waste carts for pick up. Extra organics should be bagged in a brown paper lawn or yard waste bag.




Please note that during the rest of the year, only organics waste that fits inside the green organics cart with the lid completely closed will be collected. Bagged or other organic materials placed outside the cart will not be collected. When extra organics need to be disposed of, residents can save organics for the following collection week, practice grass-cycling to reduce yard waste, or bring extra organics to the Eco Centre at no charge (up to three cubic metres).

Council Meetings

Review of the 2025–2027 Recommended Corporate Plan November 4-6, 2024

The 2025-2027 Recommended Corporate Plan will be presented to Spruce Grove City Council during a series of Governance and Priorities Committee meetings scheduled for November 4, 5, and 6 starting at 5 p.m.

The corporate plan outlines the resources required to deliver the City's programs and services, provide funding to the community, and implement Council's vision as described within the 2022-2025 City of Spruce Grove Strategic Plan.

During these meetings, Council will review the plan, discuss Administration's recommendations, and provide direction that will inform the revised 2025-2027 Corporate Plan, which will be presented for approval at the December 2 Council meeting.

Public Question and Answer Period

Members of the public may participate in the public question and answer period to ask a question about the 2025-2027 Recommended Corporate Plan by registering at cityclerk@sprucegrove.org or by calling 780-962-7615 before noon on November 4 to ask a question in person. When registering, please provide the question you intend to ask. Alternately, residents can submit a question to be asked on their behalf by emailing cityclerk@sprucegrove.org until the public question and answer period is complete.

In-person attendees will have two minutes to ask their question. One question per person is permitted. Questions may be answered during the meeting or may be referred to Administration for further research. In all cases you will receive a reply.
